

## **Current Report No. 12/2019 of 04.07.2019**

### **Subject :**

List of shareholders holding at least 5% of the total number of votes at the Ordinary General Meeting of Shareholders held on 28.06.2019.

### **Legal basis:**

Article 70(3) of the Act of 29 July 2005 on public offering and the conditions for introducing financial instruments to the organised trading system and on public companies (Journal of Laws of 2019, item 623).

### **Content of the Report :**

1. **Mr. Krzysztof Kwiatkowski**, - holding at this Ordinary General Meeting of Shareholders 704.462 shares giving right to exercise 704.462 votes, representing 25.12% of all the votes at this Ordinary General Meeting of Shareholders, which constitute 22.37% of the total number of votes.
2. **VALUE FIZ subfundusz 1**, - holding at this Ordinary General Meeting of Shareholders 338.788 shares giving right to exercise 338.788 votes, representing 12.08% of all the votes at this Ordinary General Meeting of Shareholders, which constitute 10.76% of the total number of votes.
3. **Bank Gospodarstwa Krajowego**, - holding at this Ordinary General Meeting of Shareholders 311.355 shares giving right to exercise 311.355 votes, representing 11.10% of all the votes at this Ordinary General Meeting of Shareholders, which constitute 9.89% of the total number of votes.
4. **FAMILIAR S.A., SICAV-SIF**, - holding at this Ordinary General Meeting of Shareholders 309.084 shares giving right to exercise 309.084 votes, representing 11.02% of all the votes at this Ordinary General Meeting of Shareholders, which constitute 9.81% of the total number of votes.
5. **AUTODIRECT S.A.**, - holding at this Ordinary General Meeting of Shareholders 257.037 shares giving right to exercise 257.037 votes, representing 9.17% of all the votes at this Ordinary General Meeting of Shareholders, which constitute 8.16% of the total number of votes.
6. **Mr. Waldemar Organista**, - holding at this Ordinary General Meeting of Shareholders 173.146 shares giving right to exercise 173.146 votes, representing 6.17% of all the votes at this Ordinary General Meeting of Shareholders, which constitute 5.50% of the total number of votes.
7. **Zolkiewicz & Partners Inwestycji w Wartość FIZ**, - holding at this Ordinary General Meeting of Shareholders 158.540 shares giving right to exercise 158.540 votes, representing 5.65% of all the votes at this Ordinary General Meeting of Shareholders, which constitute 5.03% of the total number of votes.
8. **Treasury represented by the Minister of Energy**, - holding at this Ordinary General Meeting of Shareholders 157.466 shares giving right to exercise 157.466 votes, representing 5.62% of all the votes at this Ordinary General Meeting of Shareholders, which constitute 5.00% of the total number of votes.
